# DWSD Capital Improvement Program

- DWSD has invested **more than \$400M in capital improvement projects since 2019**
  - Water main, hydrant and lead service line replacement
  - Sewer lining and replacement
  - Green Stormwater Infrastructure installations
- DWSD and our contractors have:
  - Replaced **77 miles** of water main
  - More than **1,600 lead service lines**
  - Replaced or lined **52 miles** of sewer piping
  - Installed **11 bioretention gardens**



## DWSD Infrastructure Contracting

- A prime contractor has some of the following subcontractor needs on DWSD water, sewer and/or stormwater capital improvement contracts:
  - Water or sewer pipe assessment/cleaning
  - Excavation
  - Earthwork and landscaping/planting for Green Stormwater Infrastructure
  - Pavement cutting
  - Pipe placement and tie-ins
  - Hydrant replacement
  - Sewer lining
  - Underground boring/lead service line replacement
  - Traffic management
  - Lawn restoration
  - Fence removal and replacement
  - Structure removal/replacement in easement
  - DWSD Facilities – fencing and parking lot resurfacing

  - **DWS-967 – Repair of Pavement (soft restoration) \***

  - TBD – Brightmoor Green Infrastructure
  - TBD- Bentler/Westbrook Stormwater Park Project
